Should any such penalties and interest be incurred, they would be recognized as operating expenses. Based on the results of management's evaluation, no liability is recognized in the accompanying balance sheet for unrecognized income tax positions. Further, no interest or penalties have been accrued or charged to expense as of June 30, 2023 and 2022 or for the years then ended. The Hospital's tax returns are subject to possible examination by the taxing authorities. For federal income tax purposes, the tax returns essentially remain open for possible examination for a period of three years after the respective filing deadlines of those returns.

The community survey was disseminated to residents of the hospital's primary service area via the hospital's website, social media webpages and email listservs, as well as those of local community partners. Focus group participants were all key community stakeholders of Effingham County. Three virtual focus groups were held in March 2022, with an average of 9 participants per focus group. The hospital and the CHNA steering committee recruited twenty-seven focus group participants.
