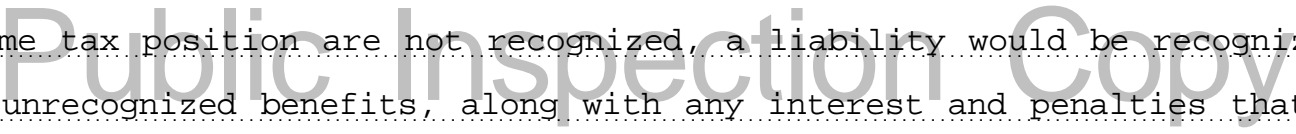

The Hospital applies accounting policies that prescribe when to recognize and how to measure the financial statement effects of income tax positions taken or expected to be taken on its income tax returns. These rules require management to evaluate the likelihood that, upon examination by the relevant taxing jurisdictions, those income tax positions would be sustained. Based on that evaluation, the Hospital only recognizes the maximum benefit of each income tax position that is more than 50% likely of

being sustained. To the extent that all or a portion of the benefits of an income tax position are not recognized, a liability would be recognized for the unrecognized benefits, along with any interest and penalties that would result from disallowance of the position. Should any such penalties and interest be incurred, they would be recognized as operating expenses. Based on the results of management's evaluation, no liability is recognized in the accompanying balance sheet for unrecognized income tax positions. Further, no interest or penalties have been accrued or charged to expense as of June 30, 2024 and 2023 or for the years then ended. The Hospital's tax returns are subject to possible examination by the taxing authorities. For federal income tax purposes, the tax returns essentially remain open for possible examination for a period of three years after the respective filing deadlines of those returns.

Key community stakeholders were also involved in reviewing and interpreting findings from the CHNA and developing an implementation plan to address prioritized community needs.

The community survey and focus group interviews assessed local health care access and needs of the Effingham County community. The community survey was disseminated to residents of the hospital's primary service area via the hospital's website, social media webpages and email listservs, as well as those of local community partners. Focus group participants were all key community stakeholders of Effingham County. Three virtual focus groups were held in March 2022, with an average of 9 participants per focus group. The hospital and the CHNA steering committee recruited twenty-seven focus group participants. They included key community stakeholders representing health care, the local public health department, faith-based organizations, the chamber of commerce, and local businesses. Collectively, perspectives obtained from the surveys and focus groups provided a holistic view of life in the community and the health and health care needs of the residents. 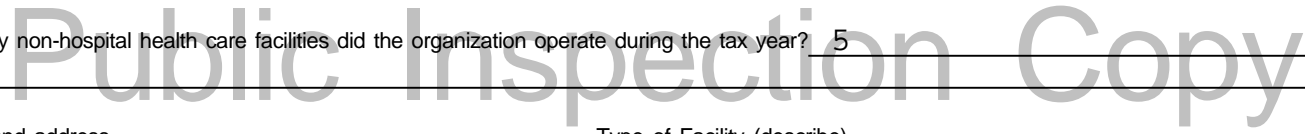
