The Hospital applies accounting policies that prescribe when to recognize and how to measure the financial statement effects of income tax positions taken or expected to be taken on its income tax returns. These rules require management to evaluate the likelihood that, upon examination by the relevant taxing jurisdictions, those income tax positions would be sustained. Based on that evaluation, the Hospital only recognizes the maximum benefit of each income tax position that is more than 50% likely of being sustained. To the extent that all or a portion of the benefits of an income tax position are not recognized, a liability would be recognized for the unrecognized benefits, along with any interest and penalties that would result from disallowance of the position. Should any such penalties and interest be incurred, they would be recognized as operating expenses. Based on the results of management's evaluation, no liability is recognized in the accompanying balance sheet for unrecognized income tax positions. Further, no interest or penalties have been accrued or charged to expense as of June 30, 2025 and 2024 or for the years then ended. The Hospital's tax returns are subject to possible examination by the taxing authorities. For federal income tax purposes, the tax returns essentially remain open

The community survey and focus group interviews assessed local health care access and needs of the Effingham County community. The community survey was disseminated to residents of the hospital's primary service area via the hospital's website, social media webpages and email listservs, as well as those of local community partners. Focus group participants were key community stakeholders of Effingham County. Three virtual focus groups were held in November 2024, with a total of 11 participants including local public health department, school district, local businesses and other health care representatives.

Information from these primary data collection efforts was supplemented by secondary quantitative data on the community's demographic and economic profile, health care access, and utilization. These data were obtained from multiple publicly available sources including the US Census Bureau, the Health Resources and Service Administration's Area Resource File, Georgia's OASIS, Centers for Disease Control (CDC), County Health Rankings, Policy Map and the National Cancer Institute.
